Rules:

There will be a mandatory course walk. Riders will be required to walk the course with the trainer named in the program. Course maps and waivers will be available at Carol Fenwick's barn. The course will be open for walking from Wednesday noon through Saturday at 10:00. Your signed waiver will serve as verification. Riders who have not walked the course will not be permitted to ride. Call 410-382-5348 with any questions.

Outrider to follow field - will remove entries that appear out of control, at his discretion.

If circling more than twice is required, it is mandatory to pull up and exit the course.

Junior Field Master's Chase parking will be located on Butler Road, approximately one mile on left from Falls Rd. - entrance will be marked. Follow signs for Junior Chase Parking.

Please return the Release Agreement that has been included with the overnight mailing.

There will be a mandatory rider/parent/guardian meeting at 1:20 in the paddock (parent or guardian must be present).

Paddock Prize for best turned out pony and for best turned out horse sponsored by **Orebanks Cattle Company and Buffalo Ranch**.

Saddled ponies and horses will be due in the paddock at 1:20 pm. First time for junior divisions at 1:45 pm with each division running in close succession thereafter. Winning riders please stay in paddock for group presentation.

REPRESENTATION, ASSUMPTION OF RISK

AND RELEASE AGREEMENT

I, the undersigned race rider, hereby sign the following representation and release in consideration of being permitted in one or more horse races, including jump races, conducted by the Grand National Steeplechase Association (here in after called "GNSA".)

I hereby certify that I fully understand that riding in races and riding or handling horses is inherently dangerous to the participants and that there is serious possibility that I will suffer injury or death as a result of participation. I hereby state that I have been given notice of the risks including, but not limited to, (i) the propensity of an equine to behave in dangerous ways which may result in injury to the participant; (ii) the inability to predict an equine's reaction to sound, movements, objects, persons, or animals; and (iii) hazards of surface conditions. I expressly agree to assume all the above-described risks and all other risks of riding in and otherwise participating in the races. I certify that I am \_\_\_\_\_ years of age.

In order to induce the above described GNSA to allow me to participate in such races and events, I represent to the GNSA that I am properly trained and competent to ride/participate in the 2017 Jr. Field Masters Chase without endangering other participants or myself. I further represent that I am responsible for my actions at any time and will provide a safe conveyance without unduly jeopardizing my safety or that of others. This agreement also represents that I will be properly equipped for the endeavor and am solely responsible for the following required equipment: (i) use of currently approved ASTM/SEI helmet; and (ii) use of a body protector.

As further inducement to the GNSA to allow me to ride in and otherwise participate in such event, I agree to release, hold harmless and fully indemnify the GNSA, the North American Pt. to Pt. Association and the National Steeplechase Association, as well as all NAPPA and NSA sanctioned sites, their committees, committee members, officers, directors, owners, employees, agents, officials and other persons acting on behalf of the Jr. Field Masters Chase from any and all liability, claims, actions, causes of action or demands, including attorney's fees and costs, that I might otherwise have or assert for any injury or other claim or other matter arising out of or related to my riding in or otherwise participating in these races. I further agree to release, hold harmless and indemnify all demands, including attorney's fees and costs that I might otherwise have or assert for any injury or other claim or other matter arising out of or related to my riding in or otherwise participating in this Jr. Field Masters Chase.

And I further waive any and all claims, actions, causes of action or demands that I may now have or which may arise in the future, and further covenant not to sue the above named organizations or trainer participating in the Jr. Field Masters Chase for any injury or damages resulting from my participation in this Jr. Field Masters Chase.
