Scratches by 11:00 am, the Wednesday before the races with the Central Entry Office (540) 439-3820.

All riders must sign Waiver of Liability forms and must provide proof of insurance before being allowed to ride.

All people who plan to be on horseback must sign Waiver of Liability forms and must wear protective headgear and vests.

All horses must be checked in with Pippy McCormick at the paddock one hour prior to their post time listed on this overnight, or they will be scratched.

The use of raised toes (toe grabs) is prohibited. Horses will be scratched or disqualified.

Please check the information on this overnight. Any changes or corrections can be made prior to scratch time to make the program.

Entries must be paid before saddle cloths will be issued.

Overnights and results are available on the Central Entry Web page-www.centralentryoffice.com.

As required by the Virginia Department of Agriculture: "All horses must be accompanied by a report of an official negative test for equine infectious anemia (Coggins Test) conducted within the last 12 months. The Certificate must accompany all horses in order to gain access to the grounds. This requirement will be strictly enforced. A health certificate must accompany horses shipping from outside Virginia.

There will be a mandatory Novice Flat Rider course walk at 11:30 am. All riders must participate. Meet in the paddock.

Trainers of horses late to the paddock may be fined \$100 the first time, \$200 the second time, and for the third offense the trainer may be suspended. Riders late to the paddock may be fined \$50 the first time, \$100 the second time and for the third offense the rider may be suspended.
