All novice riders must provide certification.

All riders must wear an SEI/ASTM approved helmet (NSA approved helmet accepted) and a protective vests. All horses must wear an overgirth.

Entries must be paid online at willowdale.org, point to point, before saddle cloths will be issued.

Proof of negative Coggins – emailed directly to lesliewhite@willowdale.org The Certificate must be received prior to race day for each horse, in order to gain access to the grounds. This requirement will be strictly enforced.

All riders are expected to walk the course. Anyone going off course may be subject to a fine.

Anyone late to the paddock is subject to a fine.
