All riders must sign Waiver of Liability forms and must provide proof of insurance before being allowed to ride.

All people who plan to be on horseback must sign waiver of Liability forms and must wear protective headgear. All race riders must wear protective vests.

All horses must be declared with Pippy McCormick at the paddock one hour prior to their post time listed on this overnight, or they will be scratched.

Race day scratches can be made with Pippy McCormick (540) 454-2854.

Entries must be paid before saddle cloths will be issued.

NO toe grabs, caulks, stickers, turndowns, inserts, trailers or heel extensions will be allowed on the front or hind shoes. Note: The insert on the toe of the Queen's Plate is considered a "wear plate," not a toe grab. Block heels on the hind shoes (not to exceed ¼ inch) are permissible. Outer rim shoes are prohibited. ONLY QUEEN'S PLATE FLAT, QUEEN'S PLATE WEDGE AND STEEL TRAINING PLATES OR THEIR EQUIVALENT MAY BE USED. Shoes will be inspected at all the point to points. Violations will result in a scratch, fine or both. Please check your shoes.

As required by the Virginia Department of Agriculture: "All horses must be accompanied by a report of an official negative test for equine infectious anemia (Coggins Test) conducted within the last 12 months. The Certificate must accompany all horses in order to gain access to the grounds. This requirement will be strictly enforced. A health certificate must accompany horses shipping from outside Virginia.

Apprentice and Novice riders must sign a Rider Accreditation form. Failure may result in a fine, scratch or both. Forms can be emailed to Don Yovanovich at dony13@aol.co or presented to Pippy McCormick at the races.

Access to the race course will not be off Route 50.

The new entrance is off Willisville Road. Turn right off Rt 50 onto Willisville Road. Then turn into the first driveway on the left.

Owners, trainers, riders, officials, sponsors and photographers will be on a list at the entrance. When you arrive, you will sign a Covid 19 Waiver Form and a Health Questionnaire. You will also have your temperature taken. Waivers can be found on the Central Entry Office website.

Horsemen are liable for all entry fees that are made for each point to point or pair event. A scratch does not void an entry fee.
