The Race Committee reserves the right to combine or cancel any races that do not have sufficient entries.

Race 2, the Amateur/Novice Rider Hurdle, had no entries and will not be carded. Post times have been adjusted.

Ten starters allowed in races over hurdles. Thirteen starters allowed in races over timber. Fifteen starters allowed in races on the flat.

All timber races will be run over the main timber course.

The Middleburg Hunt is awarding the Journey's End Bowl to the Leading Lady Rider of the day.

* Trainers can declare their horses with Pippy McCormick prior to arrival using mobile number 540-454-2854. Race day scratches can also be made with Pippy McCormick.

* NOTE Rule 1. Horsemen are liable for all entry fees that are made for each point to point or pair event. A scratch does not void an entry fee.

* Please review Rule 25 on page 2 of the condition book regarding the mandatory shoe rule.

* Attention Riders and Trainers: You will be fined if late to the paddock. Please see Rule 28, page 2, in the Condition Book for complete details.

* All novice riders need a certification form, contact Don Yovanovich for assistance. Rule 37 page 2.

* All Riders must sign Waiver of Liability forms and must provide proof of insurance before being allowed to ride.

* All people who plan to be on horseback must wear protective headgear. All race riders must wear protective vests.

* Entries must be paid before saddle cloths will be issued. Entry fee \$100 in all races.

* As required by the Virginia Department of Agriculture: "All horses must be accompanied by a report of an official negative test for equine infectious anemia (Coggins Test) conducted within the last 12 months. The Certificate must accompany all horses in order to gain access to the grounds. This requirement will be strictly enforced. A health certificate must accompany horses shipping from outside Virginia.
